**INTRODUCED BY COUNCILMEMBER \_\_\_\_\_ :**

**WHEREAS,** the 2016 adopted budget provided for a full time salary for the Commissioner of Finance; and

**WHEREAS,** the City of Poughkeepsie is desirous of having a permanent full time Commissioner of Finance to replace the current Commissioner of Finance; and

**WHEREAS,** the City of Poughkeepsie has requested an amendment to the budget to provide for an adjustment in the budget line items to accommodate for the increase in salary for the Commissioner of Finance position; and

**WHEREAS,** the amendment of the budget decreasing monies from the Contingency portion and increasing monies in the Salaries-Mngmt, Social Security Tax and Medicare Tax portions will not have a financial impact on the 2016 adopted budget; and

**NOW, THEREFORE,**
