GENERAL CONDITIONS

Temporary Dumpster:

- 1. The dumpster must be at least ten (10) feet away from a fire hydrant and cannot block access to visible valve locations.
- 2. The dumpster shall not be placed in such a way that it blocks traffic.
- 3. Warning devices shall be used. Such as, but not limited to, reflective signs, cones, tape, etc.
- 4. No debris or trash shall be left on the street, sidewalk or area around the dumpster.
- 5. Repairs or reimbursement shall be made to the City of Poughkeepsie for any damage to City property including pavement, curbs, sidewalks, trees, utilities, grass area, etc.

Street and/or Sidewalk Closure (obstruction):

- 1. Proper work zone(s) shall be established including warning devices such as, but not limited to, reflective signs, barricades, cones, tape, etc.
- 2. Street closures (full and partial) shall be reported each day by calling 845-451-4111.
- 3. The duration of the sidewalks/roadway closure permit, or of any extension of such a permit previously granted, shall be determined at the time of application by agreement between the applicant and the Commissioner of Public Works, or his designee, based upon the nature and anticipated duration of the need for the permit. The fee for the entire duration of the permit shall be paid at the time of application or extension.

R.O.W./Excavation/Utility

- 1. Right-of-way (R.O.W.) uses include **occupancy by a private work crew** for purposes such as, but not limited to, underground services (water, sewer, electric, gas, etc.), tree clearing, trimming, aprons, sidewalks, etc.
- 2. Proper work zone(s) shall be established including warning devices such as, but not limited to, reflective signs, barricades, cones, tape, etc.
- 3. Street closures (full and partial) shall be reported each day by calling 845-451-4111.
- 4. All excavations shall be maintained for a period of two (2) years following completion of the work.

General Notes:

Exemptions shall include: Civic groups performing beatification or clean-up work that does not involve a dumpster; Temporary signs, banners, holiday decorations; General maintenance such as mowing, trimming, snow and ice clearing.

The City of Poughkeepsie shall be protected against any claims for public liability or property damage arising out of, or because of the issuance of this permit.

This permit may be revoked without warning in the event that any of the above conditions have not been met by the permit holder.
